5. President's Report

The President presented his report, focusing on -

- The busy six-month period with 'business as usual' being progressed, along with the major body of work relating to the transition to One Sailing.
- The proposed re-development of the Boatshed at Albert Park to also serve as a state sailing headquarters and home for the YV office. Including the government supported financial model.
- In specific relation to One Sailing -
 - A lengthy process in relation to developing the Implementation Agreement was now at version 7 and close to a conclusion.
 - The YV 'safeguards' would be preserved as part of the process and to ensure this the YV Board had insisted on some changes to the original version.
 - Connected to the Implementation Agreement is the series of Schedules and in particular the schedule relating to services to clubs and services to the sport in general. The Board was working hard to ensure that this met with member expectations and the 'safeguards' were integrated.
- The outstanding effort of several clubs to deliver state, national and international events over the summer and in particular Royal Yacht Club Victoria for the Para Worlds
- The overall effort of the YV Board. This included Jenni McLean's brief period on the





Board before resigning so as to join the YA Board. As well as the addition and immediate contribution of Linda Goldsmith.

• Thanks to all committees, the Board, the CEO and staff.

Mark Taylor (BRYC) enquired as to whether it was too early to vote on the proposed YV Rules changes, given that the Implementation Agreement and Schedules were not fully agreed. The President replied that the proposed changes facilitated the YV Board to advance to One Sailing, once agreement had been reached and the content of the Implementation Agreement and Schedules were to the satisfaction of the Board.

Brian Goland (QLYC) enquired as to the future role of the YV office and staff, as well as the Board. The President outlined the role of various staff members and assured the members that the One Sailing model was designed to provide stronger resourcing and support to clubs. Further, the President outlined the future role of the Board in the quality assurance area and in terms of keeping YA accountable.

Campbell Miles enquired as to YV assets and cash reserves. The President advised that the likely outcome would be YV retaining these unless otherwise agreed to the satisfaction of the YV Board.

8. CEO Update

The CEO Steve Walker -

- Outlined further progress in the important areas of Participation, membership and Retention.
- Outlined further progress in the Inclusion area including Sailability, Women and Girls in Sailing, and the adoption of the Inclusive Club Standard.
- Advised that Tackers and other course numbers were continuing in the right direction and re-emphasised the need to continue to drive Tackers strongly.
- Advised that Race Officer development continued in the right direction.
- Spoke favourably with regard to the many successful events over the summer conducted at a variety of clubs.
- Outlined the review that is underway with regard to Junior/Youth coaching.
- Advised that YV had an opportunity to elevate the Sailing World Cup Melbourne event and that a significant effort was going into this.
- Thanked the Board, Staff, Committees and clubs.

The CEO report was accepted.

9. General Business

Sailing Department Update

Sailing Manager Lesley Fasala advised that numbers were stable in the Club Marine Series, as well as the Port Phillip Women's Championship Series. This extended to most junior and youth regattas, plus school sailing. Lesley advised that Victoria's Race Officer numbers far exceeded all other states including NSW. Lesley advised that activity was generally strong at regatta and event level and that this remained a focus area for clubs and YV. The update was noted.





Inclusion Update

In the absence of Inclusion Manager, Sam Watson, Lesley Fasala reported that progress was being made in the Sailability area with one new program, one program becoming a club, and numbers overall up. Lesley also advised that numbers continued in the right direction with regard to Women and Girls in sailing in the leadership and participation areas. The update was noted.

Discover Sailing Department Update

Discover Sailing Manager Gavin Wall provided a salient reminder that Discover Sailing Days are not a conclusion, however part of an important process to future proof clubs. Gavin provided some examples of very successful clubs, following their full adoption of Discover Sailing principles and programs. Gavin also updated with regard to the strong numbers of Discover Sailing Centres, Instructors, Courses and Club Coaches. Gavin outlined some of the Discover Sailing plans for 16/17 including state days on Nov 13 and Jan 8. The update was noted.
