1. Open Meeting & Welcome by President, Ian Cunningham

4. Business Arising from the Minutes

5. President's Report

Ian Cunningham welcomed Jenni Maclean from the Australian Sailing Board

The President presented his report, focusing on -

• Transition to One Sailing - Initially the changes proposed were met with substantial scepticism by all MYA's (State Member Yachting Associations) based on largely legacy issues, sometimes from many years prior, but also on concerns about the ability of YA (as it was then) to deliver the services required.

The YV Board took the leading role on behalf of all MYA's in developing both the Core Safeguards (schedule 1 of the implementation agreement) and the Implementation Agreement now accepted by all MYA's, to ensure the mitigation of risks associated with the achievements made by YV on behalf of its Member Clubs and Associations. Broadly the agreement (which is the same for each MYA) confirmed the desire by all parties to enshrine the existing levels of service and to establish a mechanism to seek improvements where possible.

Importantly, this change to One Management has not meant "central management", with senior national roles being retained by ex-YV staff who are still housed in the YV offices.





In moving forward, the YV board is committed to ensure:

- 1. the Implementation Agreement achieves the benefits hoped for,
- 2. the continued use of volunteers via active committee participation that will assist development of national policies and enhance local communication,
- 3. valued representation of member clubs and associations to AS and State Government, and
- 4. the continued delivery of successful and relevant events in conjunction with AS.

In addition to the forgoing, YV has a constitutional commitment to the sport of sailing via Yachting Victoria Inc., a member of AS, and together with the other MYA's, can either control or have significant influence over AS through its constitution.

 The Sailing World Cup – The unfortunate loss of the Sailing World Cup from Melbourne from 2017 has seen the executive committee move into a planning stage around what event will be staged next year. Yachting Victoria still owns the 'Sail Melbourne' trade mark, which allows this event to be resurrected if that is the decision moving forward.

lan thanked the Yachting Victoria board members for their support over the last two years and the role the Yachting Victoria staff played in the growth of the sport in Victoria. Special thanks were given to Steve Walker (ex Yachting Victoria CEO) for his dedication over 4+ years.

6. Treasurer's update – on Year End June 2016

The report, as previously circulated via email/link was discussed. The Treasurer gave an overview of the report focussing on:

- \$8,281 surplus versus a budgeted surplus of \$10,103. However this is a major turnaround from last year's deficit of \$50,566
- Year of transition as at 1st June operations transferred to Australian Sailing so these accounts include:
 - 11 months affiliation fees
 - 11 months employment costs
 - = Net impact approx. \$4k ⊥

Strong performances by Boatshed and Mobile Boatshed but loss recorded by SWC - mainly due to a lack of entries - \$77k under budget

2016/17 Going Forward

- Australian Sailing now responsible for operational management including financial management
- Yachting Victoria has requested monthly reports in the year of transition especially Boatshed, Mobile Boatshed and Sailing World Cup
- YV responsible for setting affiliation fees and retain financial responsibility for SWC
- Non current assets remain in YV and therefore depreciation will be charged but will be used by AS operationally.
- State Sailing Centre completion mid/late 2017

Cherry thanked David Vickers (taking redundancy) for the work he has done over many years with Yachting Victoria and wished him all the best in his future endeavours.

(b) Regional Managers Report

Regional Manager Gavin Wall gave a report outlining the success of Discover Sailing Days and course numbers over the 2015-16 season. He outlined the success of the first year of the 'Get Active Sailing' initiative and the growth in Race Officials.

Gavin then gave an outline of the new staff positions in the new Australian Sailing structure.

Glenys Hitchens asked Gavin Wall about the percentage of females in Official positions within the sport of Sailing in Victoria. Gavin indicated that we had over 30% of females in these positions, including instructors, club committees, boards, sub-committees. Glenys asked what the percentage was within the race official's community. Gavin indicated that he did not have an exact figure to hand that that stage.

Rod Thomas asked what the current SWC event was looking like and what was planned for the future now that it Melbourne no longer had the rights to host the event. Mark Klemens (Chair of the SWC executive committee) gave an overview of this year's event and the thinking moving forward into next year.

- Current status of this year's event is good. Lasers are full, 49ers looking good, but 470's slow.
- Due to the success of last year's event, this year's support by sponsors and state and local government is good.
- World Sailing is 100% behind this year's event

Moving Forward into next year:

- Invited classes will be fundamental to the event
- Australian Sailing is committed to the creation of a new event
- Japan, China and New Zealand are all interested in the possibility of being involved.

Mark Klemens then went on to thank the YV Board for their hard work and that he had enjoyed his time on the board. While he is stepping down from the YV board he will remain Chair of the SWC Committee.
